

**DISTRIBUTION AGREEMENT
BETWEEN
ROMAN STONE CONSTRUCTION COMPANY
AND
JMD BUILDING PRODUCTS LLC**

This Agreement is made effective and entered into as of September 3, 2014, by and between Roman Stone Construction Company ("Seller") with its primary office at 85 S. 4th Street, Bay Shore, NY 11706 and JMD Building Products LLC with its headquarters at 13105 Delmar Street, Leawood, KS 66209-4147 ("Authorized Distributor").

- I. Seller hereby appoints Authorized Distributor as a nonexclusive representative for the sale of Seller products and/or services included in Seller's Catalog and for all products Seller is an authorized distributor including, but not limited to, temporary and permanent concrete barriers, precast concrete pavement slabs, concrete manholes, distribution boxes, catch basins, cast iron manhole covers, frames, grates, inlets, polymer concrete, FRP and HDPE products, light pole foundations, transformer pads, caps, mats and slabs, fabricated steel components and hatch covers, concrete conduit, pervious concrete tree grates, reef balls and specialty items.

Criteria for Participation as Authorized Distributor agrees that it meets the following pre-requisites to participate as a channel for sale of Seller products and services

- A. Authorized Distributor has and will maintain operational software to receive and transmit transactions with Seller and the authorized customer ordering entities.
 - B. Authorized Distributor will accept credit card payments from their customers.
 - C. Authorized Distributor has, or will establish, a separate filing system documentation for all sales of Seller's products.
 - D. Authorized Distributor will provide monthly reports to Seller of all reportable sales received during the prior month.
 - E. Authorized Distributor will pay all invoices within Seller's standard payment terms of Net 45 days.
- II. Sales Territory: Authorized Distributor participation in this Agreement does not change the Primary Trading Area of its Distributor Agreement with Seller. Authorized Distributor agrees to only sell product outside of Seller's Primary Trading Area, unless prior authorization to do so is granted, from Seller's President or Executive Vice President. If Authorized is determined to be selling product to customers in Seller's Primary Trading Area this Agreement may be terminated for cause.
- III. Effective Date and Term: The Term of this Agreement shall commence on the date of final signature by the authorized representative of Seller and Authorized Distributor and will remain valid unless or until terminated per Section IV.
- IV. Termination of Agreement:
- a. **Either party may terminate this Agreement, at any time without cause by written notice given to the other via certified mail, return receipt requested, no less than thirty days (30) prior to the effective date of such notice.**
 - b. Seller may terminate this Agreement immediately upon the termination for any reason of the Distributor Agreement between Seller and Authorized Distributor or if Authorized Distributor fails to perform any obligation, duty or responsibility set forth in this Agreement.
- V. Distributor Participation: Authorized Distributor hereby certifies that its participation in Agreement is voluntary and will be in accordance with all terms and conditions set forth herein.
