We are pleased to inform you that your firm has been found eligible to receive the additional NAICS code requested as a Disadvantaged Business Enterprise (DBE) by the New Jersey Department of Transportation on behalf of the New Jersey Unified Certified Program (NJUCP).

Your certification status with the NJUCP will remain in effect as long as your firm continues to meet the DBE program's eligibility requirements outlined in U.S. Department of Transportation, Code of Federal Regulations Title 49 CFR Part 26. Changes include, but are not limited to: ownership, and /or control, officers, directors, management, key personnel, scope of work performed, daily operations, ongoing business relationships with other firms or individuals, or the physical location of your firm. Failure to do so may result in the removal of your DBE Certification in accordance with §26.83(j) and §26.109(c).
