
The annual review of your Disadvantaged Business Enterprise (DBE) certification with a Woman Business Enterprise (WBE) designation has been approved by NCDOT.

In order to remain an eligible DBE/WBE firm, you will be required to submit a declaration of eligibility (DOE) along with gross receipts for its most recently completed fiscal year, to this office by your anniversary date of **June 22, 2025**. Should you experience any changes in circumstances affecting your ability to meet size, disadvantaged status, ownership, or control requirements or any material change in the information previously provided, you are required to notify this office in writing within thirty (30) days of the change. **Please be advised that non-compliance, whether full or partial, is deemed a failure to cooperate and may result in removal of your firm's DBE certification.**

As a certified firm, you are eligible to receive supportive services through our Business Opportunity and Workforce Development (BOWD) Unit. Please note that DBE certification status is not considered pre-qualification to bid, or approval to perform work for the Department of Transportation.
